### MEMORANDUM TE17 OF 2023

#### IMPLEMENTATION OF THE REVIEWED FARMING MANAGEMENT PROGRAMME IN REPORT 191 N4-N6 FROM JANUARY 2023

The Directorate Curriculum Development and Support established Curriculum Support Teams (CST's) in 2018 to begin with the review process of outdated Report 191 syllabi. Over 50 subjects have been reviewed and implemented on an ongoing basis since 2019.

As a continuation to the review process, Farming Management was identified as one of the critical programmes that required a review, especially considering the importance of Agriculture and farming and its contribution in the food security of the country. The reviewed subjects' covers Farming Management, Farming Mechanisation, and Computer practice application in farming amongst others. The reviewed content includes Animal and Plant production with Soil Science incorporated.

Request to the Director-General to sign a letter to QCTO CEO to quality assure and approve the reviewed fifteen Report 191 subjects for implementation in January 2023 was successful.

The new programme name, subject names and codes were developed, updated in the structures of Business Studies programmes and examination dates allocated accordingly.
